Peddlers Ordinance = Revised 2016

Section 1 License - Registration Required

It shall be unlawful for any person, firm or corporation to engage in business as a canvasser, peddler, or solicitor, local charitable organizations excepted, calling at any residences without the previous consent of the occupant for the purpose of soliciting orders, sales, subscriptions, or business of any kind without first having registered in the office of the village clerk.

Section 2 Definition

"Peddle" shall mean the selling, bartering, or exchanging or the offering for sale, barter or exchange of any tangible personal property upon or along the streets, highways, streets, or public places of this village or from house to house, whether at one place thereon or from place to place, from any wagon, vehicle, pushcart, or any other vehicle moveable receptacles of any kind, but shall not include the delivery of any item previously ordered or the sale of items along delivery routes where the purchaser has previously requested the seller to stop and exhibit their items.

Section 3 Applications

A person desiring a peddler's license may obtain the same by making application with the clerk at the Water Department and providing the following information

- A.) Name of company and name of all persons involved that are wanting to peddle a product in the village.
- B.) Permanent home address and address of the company, business or organization.
- C.) A brief description of the business and the goods to be sold.
- D.) The length of time for which the right to do business is desired.

Public Welfare Chapter 6

Section 7 Unwanted Peddling

Nothing contained in this chapter, nor the issuance of any license/permit hereunder shall entitle the licensee to go in or upon any private residence for the purpose of peddling if such licensee, his agents or employees are directed to depart from said private residence by the owner or person in charge.

Section 8 Peddlers as a Nuisance

- A.) The practice of going in and upon private residences, business establishments or offices in the village by solicitors, peddlers, hawkers, itinerant merchants and transient vendors of merchandise without having been requested or invited to do so by the owner or owners, occupant or occupants of said private residences and business establishments or offices for the purpose of disposing of and/or peddling or hawking of merchandise is hereby declared to be a nuisance and is punishable as a violation of this ordinance. No person shall peddle in a public square nor on the grounds of the Village Hall.
- B.) If a concerned resident of the village, calls the village half or police department and makes a verbal or written complaint on the actions, forceful sales tactics or threatening comments that would make the reporting citizen feel threatened or concerned for their safety or welfare in any way the peddler or hawker that is or was at their residence peddling will be considered a Nuisance and their peddlers permit/license will be revoked for the period stated on their permit/license and future privileges will be revoked for a period of ninety (90) days thereafter.

Section 9 Photographs & Identification

All permitted peddlers or hawkers shall visibly display a photo identification of themselves that states their name and the company or organization that they are representing when peddling or hawking in this village. Violation of this section will result in revocation of the peddlers permit/license for the permitted time stated on the application.

Public Welfare Chapter 6

Section 15 Seperability

The invalidity of any provision of this ordinance shall not affect the validity of the remainder of this ordinance.

Section 16 Effective

This ordinance shall take effect 30 days after its final passage, approval and publication as provided by law.
