## **ANNUAL APPROPRIATION ORDINANCE**

An Ordinance making appropriations for all corporate purposes for the Village of Crainville, Illinois, for the fiscal year commencing on the 1<sup>st</sup> day of May, A.D. 2023 and ending on the 30<sup>th</sup> day of April, A.D. 2024.

Be in ordained by the Village President and Board of Trustees of the Village of Crainville, Illinois, as follows:

Section 1. That the amounts hereinafter set forth, or so much thereof as may be authorized by law, as may be needed, are appropriated for the corporate purposes of the Village of Crainville, Illinois to defray all necessary expense and liabilities of the said Village of Crainville, Illinois, as hereinafter specified, for the fiscal year commencing on the 1st day of May, 2023, and ending on the 30th day of April 2024.

Section 2. The amount appropriated for each object and purpose is as follows:

Section 3. That all sums of money not needed for immediate purposes may be invested in Securities of the Federal Government in Federally insured Savings and Loan Associations or in Certificates of Deposits of any bank defined in the Illinois Banking Acts.

Section 4. If any sections, subdivision sentence or clause of this Ordinance is, for any reason, held invalid or to be unconstitutional, such decision shall not affect the validity of the remaining portion of this Ordinance, which remaining portions shall be deemed separable and shall remain in full force and effect.

Section 5. This Ordinance shall be in full force and effect from and after its passage, approval, publication and recording according to law.
