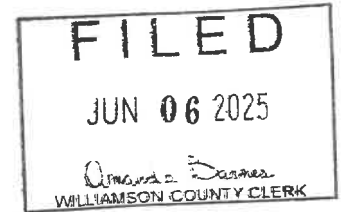

## ORDINANCE NO. 2025-05-02

### **AN ORDINANCE LEVYING TAXES FOR THE FISCAL YEAR 2025-2026**

WHEREAS, the Board of Trustees of the Village of Crainville Illinois, duly passed the Annual Appropriations Ordinance on May 13, 2025.

NOW, THEREFORE, Be it Ordained by the President and the Board of Trustees of the Village of Crainville, Williamson County, Illinois, as follows:

Section 1: That there be and hereby is levied upon all taxable property within the corporate limits of the Village of Crainville, Illinois, for the fiscal year 2025-2026 the total sum of \$88,215.13, for the following and specific purposes, including General Corporate, Audit, Police Protection, Fire Protection, Street and Bridge and Civil Defense, in the respective sums to follow, to wit:




Section 2. That the amount appropriated and not expressly itemized and carried forward in the Tax Levy Ordinance will be paid out of monies from other sources than the Tax levy. That the tax levy for the General Obligation Bonds pursuant to Ordinance 2014-05-01 of the Village of Crainville for the tax year 2025 in the sum of \$31,315.79 is hereby abated.

Section 3. That the Village Clerk of the Village of Crainville is hereby directed to file with the County Clerk of Williamson County, Illinois, notifying her of the abatement of said General Obligation Bond tax levy and further requesting rates for property located within the Village of Crainville for 2025/2026 tax bills.

Section 4. That it is the intention of the Board of Trustees of the Village of Crainville that this Ordinance and every provision thereof shall be considered separable and the invalidity of any section, clause, or provision of this Ordinance shall not affect the validity of any other portion of the Ordinance.

Section 5. That this Ordinance shall be known as Ordinance No. 2025-05-02 of the ordinance of the Village of Crainville, Illinois, and shall be in full force and effect from and after its passage, approval, recording and publication in pamphlet form in accordance with law.
