ALL STRUCTURES MUST COMPLY WITH THE BOCA OR CABO CODES, BOCA NATIONAL BUILDING CODE, THE NATIONAL ELECTRIC CODE AND THE STATE OF ILLINOIS PLUMBING CODE. PLEASE SUBMIT A DRAWING ON THE BACK OF THE APPLICATION TO INDICATE EXACT LOCATION OF STRUCTURE ON LOT AND SETBACKS,
